When the day arrived, we spent an hour or so performing a basic tune-up: plugs, plug wires, points, cap, and rotor. We also replaced the ancient battery. Before attempting to start the car, we verified that the oil pressure light and gauge were, in fact, working. Once verified, we turned the key and the old Corvair spluttered to life – sort of. Although the engine would turn over, it simply refused to start.
