

ur annual Corvair Parts Auction returns on Saturday, February 18, at the great venue we first visited last year, the Pompton Lakes Elks Lodge at 15 Perrin Ave., Pompton Lakes, NJ 07442.

The Elks Lodge has easy access from major highways for an easy drive and has a large parking lot. It provides a spacious and comfortable indoor space, with plenty of tables to display the auction wares, and comfortable seating. No need to bring a chair!

The Elks will have **breakfast and lunch** items for sale which will benefit the charities they support including Veterans, Youth, and Community Programs. Come hungry!

We will of course have our usual entertaining auctioneers for your enjoyment. Get all those parts and cash ready and be sure to join us for a great time.

As in the past, at the auction our shameless auctioneers will offer Corvair parts and Corvair-related items to the highest bidder, with a 10% commission of the sale price going to the club treasury. You may bring parts to sell, you may buy, or you may do both, or you may just

come to enjoy the fun.

Plan on making a day of it. Due to the nature of how the auction operates, it is not possible to process any buyers or sellers until the auction is completed. Only when all lots have been offered and the bidding is complete, typically around 2:30 PM, can we tally the sales, collect from the buyers, and pay the sellers.

Plan on getting there early. As we said we'll open the doors at 8:30 AM, to allow time to tag and display any parts you are selling, have some breakfast, and to peruse the parts being offered.

If you're selling, you will need to fill out an Auction Lot Card for each part or group of parts being sold as one, so please allow sufficient time to do this before the start of bidding.

The Auction Lot Card form is available on the NJACE website so you can print what you need and fill them out in advance. Just use this link:

But you can also get blank lot cards on the day of the auction.

Each attendee will be issued a Bidder Number by which the auction desk will track all purchases.

We ask that items being offered be limited to Corvair parts or Corvair-related items, only. We're enforcing this, any non-Corvair-specific items will be accepted only if a full donation to the club. Also, we ask that you not bring more than one of the same item to sell. You can, however, sell multiple items in a "lot." You could offer, say, one lot of six oil filters, instead of individual oil filters. (Bulk lots often sell very well!)

#### Auction, continued

Remember that only quality items sell easily. Greasy, rusty, bent and broken pieces have limited appeal, and we don't want to bring them into the Elks Lodge, anyway.

The club will deduct a 10% commission on all sales. You may also donate items for the full benefit of the club. We ask everyone to consider donating some items, to help defray the costs of the rental of the facility.

What if the weather is bad? Because this is an indoor event, it will take place regardless of the weather. Only an out-and-out blizzard, or similar curveball thrown by Mother Nature, will cause us to cancel. Generally speaking, you can assume that the event is "on," but if it is necessary to cancel we will get the word out via email and Facebook and the Corvair Center Forum.

Historically, the auction is our most popular event of the year and draw participants from far and wide. Don't miss it!

#### **Swap Meet? Flea Market?**


hatever your preferred term may be, an all-Corvair swap meet / flea market is coming up this Spring, presented by our friends in the Lehigh Valley Corvair Club.

#### **Remembering Ron**

Te were saddened to learn of the passing in early January of Ron Peles, an NJACE member for more than 45 years. Ron waged a relentless battle with cancer, but regrettably cancer still wins far too often. Just 65 years of age, he left behind Gloria, his wife of 39 years, and many relatives and friends.



Ron was active in the Corvair hobby for virtually his entire adult life. He joined the NJACE in the 1970s while still a student at Rutgers. Through the years Ron served in several capacities within the club, including as an officer, a contributor to the newsletter, an event organizer, and notably as one of the key

people who arranged the Corvair 50th Anniversary celebration in Cape May.

He entered his red '65 Corvair convertible in many of the annual time trials sponsored by the Northeast Corvair Council at Lime Rock Park, and more than once he won the John Fitch Award for best combined track time and car show score. Ron also served on the Board of Directors of CORSA.

In addition to NJACE, Ron belonged to the Lehigh Valley Corvair Club and was a founder of the Delaware Valley Corvair Club. Beyond his involvement with Corvairs, he was a member of the Antique Automobile Club of America, Avanti Owners Association International, Studebaker Driver's Club and the Garden State Crew-zers, a PT Cruiser owner's club. He was a car guy, through and through.

But he wasn't just that. Ron was a member of the New Jersey State Bar Association. He was also Municipal Prosecutor for Greenwich, Pohatcong, Phillipsburg and Belvidere Townships as well as Attorney for Greenwich. His private practice areas were real estate, personal injury, municipal court, business law, civil litigation and estate matters. He was also a devout Roman Catholic who held several positions with the Knights of Columbus.

Ron was interred at St. Mary Cemetery in Alpha, NJ on January 8. Gone too soon, he will be long remembered.

#### **My Rampside Ownership Story**

In October, 2014, Kathy and I were attending an annual Pennsylvania campground owner's convention where I found myself talking with a



couple of people who were KOA (Kampgrounds Of America) representatives. We were familiar with these people because they had been trying for years to get us to join the KOA franchise which included roughly 500 other campgrounds in America. But we always declined their offers because we enjoyed our private campground ownership.

During this discussion, Linda, one of the KOA representatives, looked at her boss who was the third person in the group and jokingly said "If you can help Ray get another Corvair maybe he'll join the KOA Franchise." He looked at me and said "You like Corvairs?" Yes, I said and he responded with "I know where there is a Rampside pickup truck no one knows about."

Linda had no idea her boss's father owned a Corvair, much less a Rampside.

His father, who was 84 at the time, was still in possession of a 1961 Rampside that he purchased new from the Chevy dealership in Lubbock, Texas. He told me his father was getting ready to move to assisted living and had to get rid of the truck so gave me his dad's phone number.

I called his dad and told him who I was and how his son had given me his phone number and I wanted to discuss the truck. He sent me a few photos and within a couple of days he and I agreed on a price of \$1200 for the truck. He was a very nice gentleman and was happy to find someone to pass the truck on to.

I phoned his son who had given me his dad's phone number and said we have an agreed price for me to purchase the truck for \$1200 and was he OK with that. I wanted to make sure no one thought I was taking advantage of an elderly adult. His son said it was fine with him because no one in his family wanted it, so the deal was done.

The older gentleman warned me he had not used it in 12 years and it was sitting in a shed in his back yard. He said it needed to be moved ASAP because of his impending move to the assisted living facility so I made a few phone calls and made arrangements for a wrecker service to move the truck to a public storage facility until I could come get it.

Before the wrecker went to move it, I had contacted a Corvair club in Texas and found a Corvair owner who agreed to go and remove the wheels and have new tires installed on the rims so the truck could be rolled. The Corvair family is always willing to help a fellow Corvair owner. Within a couple of weeks, I made arrangements to go to Lubbock with my car trailer and bring the Rampside home.

After driving 1600 miles there I was in Lubbock and looking at every panel, bumper, headlamp, door, and compartment of my Rampside. That is when I noticed the Texas license plate and the windshield state inspection sticker were both 40 years old. The seller who at the age of 84 made a mistake, after a little math I determined he drove it for 12 years then it sat for 40 years in his shed. I winched it up on my trailer, secured it with tow straps and began my 1600-mile trip back the Pennsylvania.

#### **GM Embraces the Corvair**

GM has filed to trademark "National Corvair Museum," GM Authority has learned. The trademark will likely be used to rename the Corvair Preservation Foundation Museum in Illinois following the museum's official recognition by GM.

The new trademark was filed on January 19th, 2023 with the United States Patent and Trademark Office (USPTO). The application was assigned serial number 97760955, and carries a Goods and Services description of "Museum services."

The new trademarked name will most likely be used in conjunction with a rebranding effort at the Corvair Preservation Foundation Museum. According to the Corvair Society of America, GM officially recognized the Corvair Preservation Foundation Museum in Illinois as the official Corvair museum in North America late last year, which would make this new trademarked name a perfect fit.

"It is with great joy and genuine excitement that we announce the official new name of our 'National Corvair Museum', which has just been approved by General Motors," said Corvair Preservation Foundation President and Museum Curator, Mike Hall. "We look forward to a long and productive partnership with General Motors as Corvair will now have a national home for its display of historical vehicles, engines, artifacts as well as containing an archive for the history of this air-cooled wonder."

The Corvair Preservation Foundation Museum is located at 10041 Palm Road in Glenarm, Illinois. First opening in 2016, the museum contains a multitude of Corvair cars, trucks, and powertrain displays, as well as related memorabilia. The museum was also recently added to the Route 66 Historic Traveler's Tour Guide, making it a great destination for both Corvair fans and car lovers in general.

The Chevy Corvair nameplate was produced over the course of two generations between the 1960 and 1969 model years. The Corvair stands out as the only American-designed, mass-produced passenger car powered by an air-cooled, rear-mounted engine, and was offered in a variety of different body styles, including a four-door sedan, two-door coupe, convertible, pickup truck, and even a van.
