

The most recent AIRHORN, the newsletter from Chicagoland Corvair Enthusiasts, mentions that cars from their Club have been used in the television series Crime Story. We've seen the show a few times, and although we've not seen any Corvairs, there is lots of nostalgic sheet metal driving by. CCE has recently been asked to participate in a movie called Jimmy Rearden, which we will have to keep our eyes open for news of its release.

THE REASON

My name is Orville Eliasson. For years I've shared my enthusiasm for the Corvair automobile with like-minded CORSA members throughout the United States. Together we have exchanged ideas, swapped parts, joined local clubs and journeyed long distances to attend national conventions.

I have talked to many of you over the years. Sometimes I was selling Tech Tips or maybe timing pointers. Sooner or later everyone at a CORSA meet would wander by to see what I had, in this way, I met almost everyone who attended the meet.

I have also spent hundreds of hours writing technical information on Vairs. Still, with all this effort on my part, I have succeeded in helping only a few hundred Vair owners; the remaining thousands were untouched by my efforts.

I now feel that I have come up with an idea that will help every Corvair left in the world (and of course every owner) at the same time. My wife is also convinced that this great idea will be of great help in reserving us a spot in the local poor house. I shall hope she is wrong.

THE IDEA

My wife and I have started a small company named NATIONAL COMPUTERIZED AUTOMOTIVE ASSISTANCE. It is strictly a telephonic service and might be compared to a hot line for Corvair assistance of all kinds. We have installed two 800 phone lines. One covers California and the other covers the rest of the United States, including Puerto Rico and Hawaii, except Alaska.

We have also purchased a large computer to store information on memberships, cars for sale, parts vendors, services and so on. This will be compiled from membership input and will therefore cover every area of the U.S. that contains Corvairs. We also have a large printer tied into the computer that will make printouts of all Vairs for sale in the U.S. with Turbo engines, rag tops, Die Hard batteries and all those driven by a little old lady from Cucamonga, etc.

THE COST

The membership cost for National Computerized Automotive Assistance is \$5 per year. This fee covers the monthly cost of several phone lines, the computer and printer operations, and assistance personnel. One membership fee covers all members of a family that maintains CORSA membership.

CORVAIR HOTLINE

The following pages describe a service which should be of particular interest to all Corvair drivers. I had a lengthy, informative chat with Orville, and this idea is great. Al Friend is a happy subscriber already, and we are joining. This could be your best spent five dollars of Corvair money ever. Orville Eliasson has asked for a couple of technical contacts from our Club. This should not require much time, but is highly important to the system. If you feel able to serve as a "contact", please see Al, Ellen or I.

Anyone may call Nat'l for emergency assistance and with proper identification, receive it. There will be no charge for call-ins concerning cars for sale or information on parts availability and where to purchase them, either in your area or across the nation. Eventually, anything relating to a Corvair will be listed. Placing information into the computer will take a lot of time and effort. The reason that the above-mentioned call-in can be free is that vendors wishing to be included will pay an appropriate fee to be listed, depending on the size of their Corvair business.

TELE - PHONE The ideal situation is for a member to pay from \$5 up to whatever he feels his assistance needs may be in the future. This amount will be recorded into the computer and drawn down when service is rendered. Any unused amount will be available to use in the following year for membership dues and services. Unused service money may be withdrawn at anytime by request.
Billing is costly and time consuming and will be avoided if at all possible.

NO MEMBERSHIP FEES WILL BE REQUIRED UNTIL JANUARY 1, 1987. However, I would urge all prospective users to make a service deposit in 1986 that will automatically pay your membership dues for 1987. Service for 1986 will consist mainly of emergency service. Listing cars for sale will be free.

NOTE

Emergency service **only** will be provided in 1986, and that may be spotty as we will not be on the job until late August of 1986. Also, note that the brand of car you are driving does not matter as long as you are a CORSA member. Also, please note that we wish to fill our computer with information on every Corvair type vehicle that is for sale in the U.S. I would urge that this be a club effort — one letter with all cars listed. Non-CORSA members are also encouraged to list their vehicles for sale. This service will be free to sellers.
In 1987 potential buyers should be able to receive a printout of all CORVAIR vehicles for sale in the entire United States. Also, anyone furnishing parts or services for CorvaIrs are urged to contact us about obtaining a spot in our computer files. Everyone will be listed, however, callers looking for service will be told which suppliers are financially subscribing to the service. Call-in service will be free as vendor contributions should cover call-in costs.

Give us a call and check things out. If you decide it will help you and Corvairing in general, then become a member.

Please have the following information at hand **before** you make an 800 call. Your complete address (including zip code), phone number, and CORSA I.D. number. If it is an emergency include the state, city, local zip code, number of phone you are calling from, highway number, nearest cross road, etc. Have on hand any phone numbers that may be helpful.

FUTURE PROJECTS The possibilities for service to members is almost limitless when you tie phone lines into a powerful computer storage system. One of the services that may be available someday would be tapes dealing with pertinent Corvair subjects. These could be available by simply dialing a number and listening to the automatic playback of the subject you choose. Another projected hope would be that vendor fees and non-member dues might make it possible to furnish CORSA members most services free at some future time.



