The items identified in Schedule A (hereinafter, the "Exhibition Items") have been made available to the Institution (as named above) by the Corvair Preservation Foundation for exhibition purposes only, for the period as set forth in Schedule B (hereinafter, the "Loan Period"). Specific exhibit care requirements while in possession of the Institution are listed in Schedule C (hereinafter "Care Requirements"). In consideration of this, the Institution agrees to the following conditions:

1. The Exhibition Items will remain the property of the Corvair Preservation Foundation; will be used solely for exhibition purposes; and will not be sold, disposed of or transferred by the Institution.
2. The Exhibition Items will be exhibited only at the address noted above.
3. The Institution will not remove, or permit any third party to remove, any labels, plates or markings identifying the Exhibition Items as being the property of the Corvair Preservation Foundation.
4. If an Exhibition Item is a motor vehicle or component thereof, such item will not be licensed, titled or operated on any public or private road or highway.
5. The Institution acknowledges that the Exhibition Items are not certified to comply with any federal, state, or local laws, rules or regulations.
6. The Institution assumes all risk of damage, loss or destruction to the Exhibition Items. Furthermore, the Institution shall follow the Care Requirements as listed in Schedule C while the Exhibition Items are in their possession.
7. The Institution will provide insurance coverage for the value of the Exhibition Items, as stated on Schedule A. Coverage is to include losses from fire, theft, or any damage or destruction of the Exhibition Items. The Institution will provide an insurance certificate listing Corvair Preservation Foundation as named insured.

8. The Institution accepts the Exhibition Items "AS IS," "WITH ALL FAULTS," IT BEING UNDERSTOOD THAT THEY ARE NOT COVERED BY ANY WARRANTY. THE CORVAIR PRESERVATION FOUNDATION EXPRESSLY DISCLAIMS ALL WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
9. The Corvair Preservation Foundation expressly disclaims, and the Institution expressly releases the Corvair Preservation Foundation from any and all liability associated with the Exhibition Items. In addition, the Institution agrees to indemnify and hold harmless the Corvair Preservation Foundation, its officers, directors, employees, and agents, from and against any and all claims, demands, obligations, causes of action and lawsuits, and all damages, liabilities, fines, judgements, costs (including settlement costs), and expenses associated therewith (including the payment of attorney fees and disbursements), (i) arising out of or in connection with the Exhibition Items or their use and possession, and (ii) the Corvair Preservation Foundation's enforcement of the provisions of this Agreement.
10. Unless directed otherwise in writing by the Corvair Preservation Foundation, the Institution will promptly return the Exhibition Items at the expiration of the Loan Period.
11. The institution shall be responsible for assuring that the conditions set forth above have been communicated to, and are understood by, all personnel who have access to the Exhibition Items.
